

ORDINANCE TO AMEND THE CODE OF THE TOWN OF SELBYVILLE BY AMENDING CHAPTER 166, TAXATION, BY ADDING THERETO A NEW ARTICLE II, GROSS RECEIPTS RENTAL TAX, TO IMPOSE A 2% GROSS RECEIPTS TAX ON ALL RENTAL INCOME FOR OCCUPANCY OF ANY PRIVATE AND PUBLIC LODGING FACILITIES AND HOUSING ACCOMMODATIONS, INCLUDING, BUT NOT LIMITED TO, ROOMS, ROOMING HOUSES, BOARDING HOUSES, BED-AND-BREAKFAST INNS, COTTAGES, CABINS, HOUSES, DUPLEXES, APARTMENTS (WHETHER IN CONDOMINIUMS OR NOT), STORES, GARAGES, WAREHOUSES, OR ANY COMMERCIAL BUILDINGS OR STRUCTURES WHICH RENT OR LEASE SPACE OR OTHER FACILITIES.
