Discussions on banners

- Local chapter of the Daughters of the American Revolution (DAR) have reached out about getting Hometown Heroes banners in Selbyville, like the have done in other neighboring towns
 - Committee discussed needing more information from the DAR on the program to better understand the timeline of implementation, how Hometown Heroes are submitted/selected, and price
 - Action Item: Stacey to reach out to DAR to get the specifics and better understand the town's investment in the program
 - Committee discussed banner placement if they were implemented
 - Options include around Selbyville town park and on Cemetery and Main St., starting on Cemetery
- Action item: get exact pricing on "welcome to Selbyville" banners or town banners for events

Discussions related to the review of the town's sign code

• Goal is for the committee to review the sign code for inconsistencies within itself and areas that could use clarification; if edits are defined and approved by the committee, AECOM would rework the code

- Sign code is convoluted, has lots of different size requirements for signs, setback requirements, and definitions listed at the start and not later in the document
- We could group the signs by like kind in the document
- Stacey did reach out to AECOM after the June Economic Development meeting, and they will get a proposal together for their work to rewrite the code once the committee gives edits
- All sign permits go through the Building Inspector, not Planning and Zoning Committee
- Code comments/edits:
 - Maintenance, like repainting signs in the same color should not need a permit by the building inspector; "aesthetic maintenance" doesn't need a permit
 - \circ Does the temporary sign section need to be adjusted for development or construction?
 - The committee could still make a supplemental document for businesses, to lead them through the sign permitting and approval process; describe where to start based on the district they're in, what steps to follow, etc.

Discussions on permitted uses in the Historic Business District

- Have AECOM also look at the historic business code and make sure it's compatible with the general sign code
- Church St. is in the Historic Business District

Discussions on any action items from June 17, 2024, meeting

- J. Conn Scott 100th anniversary recognition at August town council meeting
- Could dedicate an area in Town Hall for plaques or commemorative items for businesses and organizations that have longevity

Other Discussion

- Dr. Cary reviewing the Economic Development Toolkit to help the committee move faster on some ongoing tasks
 - Committee reviewed some drafts of mission statements and taglines for the town
 - Favorite tagline: "Rooted in History, Growing with Opportunity"
 - Favorite mission statement: "The mission of Selbyville is to honor our rich history and traditions while actively building a vibrant, inclusive future for all. We are committed to fostering community growth, supporting local businesses, and ensuring a high quality of life for every resident."
 - Favorite vision statement: "By 2026, through a collaborative process with residents, businesses, community organizations, and schools, Selbyville will enhance and
